Wille welcomed everyone to the meeting and thanked them for coming.

AUTHORIZING THE ISSUANCE OF SERIAL BONDS (RENEWAL) OF THE TOWN OF EAST BLOOMFIELD IN AN AMOUNT NOT TO EXCEED \$188,000 TO PARTIALLY PAY FOR THE PURCHASE OF A 2023 INTERNATIONAL MODEL #HX520 SFA PLOW TRUCK

WHEREAS, the Town Board (the "Board") of the Town of East Bloomfield (the "Town") having previously authorized the purchase of a 2023 International Model #HX520 SFA Plow Truck (the "Equipment") for the Town's use and the financing thereof to partially defray the costs of the Equipment by issuance of serial bonds in the aggregate principal amount of \$235,000 pursuant to a bond resolution dated January 9, 2023 (the "\$235,000 BAN"); and

WHEREAS, the \$235,000 BAN will mature on January 26, 2024.

NOW, THEREFORE,

BE IT RESOLVED, by the Town Board of the Town of East Bloomfield located in the County of Ontario, New York, by the favorable vote of not less than two-thirds of all the members of such Board, as follows:

Section 1. The Supervisor is hereby authorized to pay the sum of \$47,000 on the principal balance of the \$235,000 BAN, plus interest of \$9,870.00, to Canandaigua National Bank and Trust Company on January 26, 2024, and shall renew the Bond Anticipation Note with Canandaigua National Bank and Trust Company for a one-year term. The renewal serial bond amount shall be \$188,000 with an interest rate of 4.15% and shall mature on January 24, 2025.

Section 2. This Resolution shall take effect immediately upon its adoption.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of East Bloomfield hereby adopts said Local Law No. 01 of 2024, entitled, "Amendment to NY General Municipal Law 103; Section 1, a copy of which is attached hereto and made a part of this resolution, and be it further,

RESOLVED, that the Town Clerk be, and she hereby is directed to enter said Local Law in the minutes of this meeting and in the Local Law Book of the Town of East Bloomfield, and to give due notice of the adoption of said local law to the Secretary of State of New York.

Motion was made by Wille, seconded by Lester, to make the following appointments to the Planning Board: Michelle Rhoda to take Matt Rogers' place, Kim Gebo to take Steve Lester's place and Brian Westlake to take Michelle Rhoda's place. Discussion was held. Motion Approved: Ayes 5 (Fessner, Conradt, Lester, MacMillan, and Wille,) Nays 0 Wyatt Conklin said he was told the mowing contract was going to be voted on tonight. Why wasn't it addressed? Fessner replied "because he got his third quote at 5:00 PM tonight so the Building & Grounds hasn't had time to review it." Conklin requested that when taking your best value into consideration not getting your quote in on time should be considered as part of that best value. Fessner replied he might interpret that as the work might not be on time either. Duvall asked if the list of the twelve people he supplied as vendors was followed up on. Wille replied "he did not follow up on anything." Fessner said one was already on the list. Duvall replied he knew that, and he called six of those vendors and not one had heard from Fessner. Fessner replied "he did not call all those on the list." Fessner went on to say he called five vendors when he first did this. Two refused to bid. Duvall asked who? Fessner said he did not know if that should be public or not. Duvall asked why not? Duvall said one is here, he knows George, he knows Welch declined. Fessner said "and so did Pro Cutters" and Lake View just sent there's in tonight. Duvall asked about a few others and Fessner replied he did not have time to contact them to get quotes. Fessner said he followed our Procurement Policy and has three quotes as it does not say we have to solicit from twelve different companies. Duvall said, "you told me that if I sent you a list you

would do your best to contact those people to get more quotes." Fessner does not remember saying that at all. Fessner recalled saying "he would use it in the future." Fessner said they will seek approval to award a vendor at the next town board meeting. Kim Duvall asked how this will be awarded since all the quotes were received prior to the adopted Local Law #1 tonight. Lester replied, "in his opinion it will be awarded by the lowest quote." Discussion was held.
