COMMITTEE REPORTS:

<u>Audit:</u> Conradt reported the Annual Financial Report (AUD) has been filed on time with the NYS Comptroller.

Buildings and Grounds: Nothing to report.

<u>HIGHWAY:</u> Kimball reported the generator at the Highway Department is scheduled to be replaced in 2024. Kimball noted for the time being the generator should be turned on manually in an emergency. Discussion was held.

<u>IT/TECHNOLOGY:</u> Wille reported all town employees' emails were not working again today. Wille reported he will be contacting Sean Barry from the Ontario County IT Department to schedule an evaluation of the towns IT needs. Discussion was held.

INSURANCE: Mitchell reported the applicable inventory regarding the Highway Department has been submitted. Mitchell has been told to expect a 6-8% increase for insurance. Discussion was held.

PARKS and RECREATION: Gochenaur reported she has been in contact with Brian from Bloomfield Baseball & Softball. The North Baseball field project still needs to be completed. The town leveled the field and re-seeded it last fall 2022. They will need skinned base areas for a multi-use field 40/60 & 50/70; including a mound by April 15th to have the season. The Bloomfield Varsity baseball coach agreed to assist with laying out the field in terms of dimensions, and we can pull together a crew of parents to assist with the labor if needed. Discussion was held. Kimball reported that he will volunteer to help finish the project. Gochenaur reported she is starting to receive calls asking if we are going to have the Summer Recreation Program this year. Wille reported the job opening has been sent to 16 Towns, 8 Villages, and 2 Cities. Andy Doell will also be sending out job packets. Discussion was held.

Ryan Duvall is asking the Town Board to pick 1 mowing contractor based on the bids that have already been accepted and opened. Duvall went on to say if there is any additional work that should be sent out separately to bid on or work with the contractor you have already picked. Discussion was held. Kimball and Gochenaur reported they received an email from Wyatt Conklin withdrawing his mowing bid application for 2023. Discussion was held. Kimball reported Shawn Rubenstein told him he will not be working for the Highway Department this summer. Discussion was held.

<u>WATER/SEWER VILLAGE OF BLOOMFIELD:</u> Mitchell reported he is waiting to hear back from MRB regarding the Elm Street out of district water users. Mitchell is still working on the sewer request from Grow Bloomfield. Discussion was held.

PERSONNEL: Nothing to report.

COMMUNICATIONS: None.

ROUND TABLE – OTHER BUSINESS: Wille wished Kimball well in his new employment position. Mitchell reported the residents have benefited tremendously from his time in office.
