WATER/SEWER VILLAGE OF BLOOMFIELD: Mitchell reported the possible new sewer district that would involve eighty properties from Mud Creek west to Oakmount Road, and the south end of Route 444 inquiry that was raised by Grow Bloomfield has been tied up for now. Mitchell reported he presented Grow Bloomfield with an estimated unit cost which far exceeds the State Comptroller's threshold. Discussion was held. Mitchell reported the town attorney is still working with the State Comptroller's Office regarding the five properties for proposed Water District #4. Discussion was held. Mitchell reported he was informed another increase in water billing is coming from the City of Canandaigua to their direct municipal customers that include the Town of Canandaigua who in turn supplies East Bloomfield. Once the rate increase is decided East Bloomfield will receive notification from the Town of Canandaigua of the rate increase that will likely be effective for water use beginning January 1, 2024. Discussion was held.
