TO ADOPT THE 2017-2018 ONTARIO COUNTY SNOW AND ICE CONTRACT

WHEREAS, the Town of East Bloomfield has contracted with Ontario County for many years to provide snow and ice control on their 8.12 miles of County roads within the Town, and,

WHEREAS, Ontario County and the Town of East Bloomfield are desirous of extending that contract through the 2017/18 season, from October 1, 2017 through September 30, 2018; and

WHEREAS, the agreement provides for payment to the Town for these services by Ontario County of \$5,600 per mile; and

WHEREAS, in the event of a County-declared snow emergency, the County may agree to pay for extended services, such as snow hauling from intersections, on a time/material basis; now, therefore, be it

RESOLVED, that this Town Board hereby authorizes the Town Supervisor to execute the Agreement to provide Snow and Ice Control Services with Ontario County, and, be it also

RESOLUTION 2017-059

TO AUTHORIZE THE EAST BLOOMFIELD TOWN COURT TO APPLY FOR A 2017 JUSTICE COURT ASSISTANCE PROGRAM GRANT

WHEREAS, the New York State Office of Court Administration has offered grant funds through their Justice Court Assistance Program to improve the local court infrastructure, and

WHEREAS, the East Bloomfield Town Court wishes to file an application for the New York State Unified Justice Court Assistance Program Grant; and

WHEREAS, the Town of East Bloomfield's Court area and Judges' Chambers need renovations to provide additional work and storage space, and a safer environment for the Court staff; and

WHEREAS, the Town of East Bloomfield, under standard procurement procedures, will hire a contractor to renovate the Court area and Judges' Chambers to provide additional work and storage space and better security with the total project cost of the project not to exceed \$30,000; therefore, be it

RESOLVED that the East Bloomfield Town Board does hereby authorize the East Bloomfield Town Court to file an application for funds from the New York State Unified Justice Court, in accordance with the provisions of the Justice Court Assistance Program in an amount not to exceed \$30,000, and upon arrival of said request to enter into and execute a project agreement with the State for such financial assistance to the Town of East Bloomfield.

Wille asked the Board for available dates in October to hold 2018 Budget Meetings. Discussion was held. The 2018 Budget Workshops will be held on Monday, October 2nd and Monday, October 16th at the Town Hall, 99 Main Street, East Bloomfield, both beginning at 6:00 PM. Wille asked if the Board wanted to move forward in a Local Law to Adopt a Tobacco-Free Policy. Discussion was held. It was mentioned that it might be an issue for the Highway Department. Discussion was held in regards to designating an area for tobacco use. Bernard reported that he didn't think that would work. Discussion was held. Wille reported that he and Bernard will meet with Brigid Heenan from the Tobacco Coalition to see what their options are. A discussion was held about the purchase of Defibrillators for the Town Hall, Highway Garage, and Veterans Park. MacMillan will do some more research about the units and will report back at the next board meeting. Wille reported to the Board that he was just informed by Bill Wright, the Ontario County Commissioner of Public Works that the upgraded software for Fuel Island does come with a cost of \$5,334 plus the \$70 per month fee. Wille reported that the town doesn't have the money for this unexpected expenditure. Extensive discussion ensued. Bernard will reach out to other Highway Superintendent's to see what they use for software. The Town Board has asked Wille to negotiate a better deal. MacMillan reported that if the Town ends up paying for any part of the system then we have to have control of the system. Discussion was held. Wille reported that the BCS Yearbook is asking the town to consider being a sponsor for the "2018 Torch". Discussion was held. Motion was made by Mitchell, seconded by MacMillan, to authorize the expenditure of \$50 to take out an ad in the '2018 Torch' featuring a picture of Ron Hawkins, with the stipulation being that a copy of the "2018 Torch" be sent to the Historical Society. Discussion was held. Motion Approved: Ayes 5 (Fessner, Mitchell, Hawkins, MacMillan, and Wille) Nays 0
