Unified solar permitting is available statewide for eligible solar photovoltaic (PV) installations. Municipal authorities that adopt the unified permit streamline their process while providing consistent and thorough review of solar PV permitting applications and installations. Upon approval of this application and supporting documentation, the authority having jurisdiction (AHJ) will issue a building permit for the solar PV installation described herein.

- Required Construction Documents for the solar PV system type being installed, including required attachments.

APPLICATION REVIEW TIMELINE

Generally, permit determinations will be issued within 14 calendar days upon receipt of complete and accurate applications. The municipality will provide feedback within 7 calendar days of receiving incomplete or inaccurate applications.

SUBMITTAL REQUIREMENTS SOLAR PV 25KW OR LESS (ATTACHMENTS)

NY State Unified Solar Permit

This information bulletin is published to guide applicants through the unified solar PV permitting process for solar photovoltaic (PV) projects 25 kW in size or smaller. This bulletin provides information about submittal requirements for plan review, required fees, and inspections.

PERMITS AND APPROVALS REQUIRED

The following permits are required to install a solar PV system with a nameplate DC power output of 25 kW or less:

- a) Unified Solar Permit
- b) Site Plan Review by Authority Having Jurisdiction (AHJ)
- c) Variance Application and approval, if applicable
- d) Mandated proof of insurances by contractors (See www.townofeastbloomfield.org for more details)

SUBMITTAL REQUIREMENTS

In order to submit a complete permit application for a new solar PV system, the applicant must include:

- a) Completed Standard Permit Application form which includes confirmed eligibility for the Unified Solar Permitting process. This permit application form can be downloaded at www.townofeastbloomfield.org
- b) Stamped Construction Documents, including all equipment specification sheets, panel layout diagram, and letter from NYS registered Architect or Professional Engineer stating array is ok to be roof mounted solar (if applicable). All other construction documents must be by stamped and signed by a New York State Registered Architect or New York State Licensed Professional Engineer.

PLAN REVIEW

Permit applications can be submitted to Building and Zoning in person at 99 Main Street, Bloomfield, NY 14469, or electronically at ebtcodeofficer@townofeastbloomfield.org

FEES

Fees for solar arrays are calculated by taking the square feet of each panel X # 0 panels X # 0. Please contact the Building and Zoning Department for confirmation of the building permit fee.

INSPECTIONS

Once all permits to construct the solar PV installation have been issued and the system has been installed, it must be inspected before final approval is granted for the solar PV system. On-site inspections can be scheduled by contacting Building and Zoning at (585)657-7700, #4 or electronically at ebtcodeofficer@townofeastbloomfield.org. Inspection requests received within business hours are typically scheduled by the next business day. If the next business day is not available, inspection should happen within a five-day window.

Electrical inspections (Rough and Final) are required to be completed by one of the approved third-party electrical inspection agencies that conduct business in the Town of East Bloomfield. Please check with the Building and Zoning Department for a current listing approved electrical inspection agencies.

A list of inspections will be provided at the time the building permit is issued.
